**THIRD AMENDMENT TO
CERTIFICATE OF LIMITED PARTNERSHIP
FOR
TAMPA BAY DEVIL RAYS, LTD.
(formerly known as Tampa Bay Sports Investors, Ltd.)**

Pursuant to the provisions of Section 620.1202, Florida Statutes, this Florida limited partnership hereby adopts this Third Amendment (the "Third Amendment") to the Certificate of Limited Partnership (the "Certificate") heretofore filed with the Florida Secretary of State on or about August 10, 1994, for Tampa Bay Devil Rays, Ltd. (formerly known as Tampa Bay Sports Investors, Ltd.) (the "Partnership"), as heretofore amended by a First Amendment filed with the Florida Secretary of State on or about March 10, 1995, and by a Second Amendment filed with the Florida Secretary of State on or about January 5, 2006, with the Third Amendment being made and entered into this 17th day of October, 2007, by Naimoli Baseball Enterprises, Inc. (formerly known as Tampa Bay Sports Investors, Inc.), a Florida corporation ("NBE"), and 501 SG, LLC, a Delaware limited liability company ("501SG"), NBE and 501SG being all of the general partners of the Partnership, as follows:

1. Paragraph 1 of the Certificate is hereby amended by deleting said paragraph in its entirety and by substituting therefor the following:

"1. Name of Partnership. The name of the Partnership shall be TAMPA BAY RAYS BASEBALL LTD."
2. All other provisions of the Certificate, as filed with the Florida Secretary of State on or about August 10, 1994, shall remain in full force and effect and shall not be amended or modified hereby.
3. This Third Amendment shall be effective as of November 8, 2007.
