ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS, effective April 30, 1998 is made by and between eBay Inc. a California corporation having a principal place of business located at 2005 E. Hamilton Blvd., Suite 350, San Jose, California 95125 ("eBay California"), and eBay Inc., a Delaware corporation having its principal place of business at 2125 Hamilton Blvd., San Jose, California 95125 ("eBay Delaware").

WHEREAS, eBay California and eBay Delaware are parties to a certain Agreement of Merger made and entered into as of April 1998 (the "Agreement of Merger"), under terms of which eBay California will sell and transfer, and eBay Delaware will purchase the Assets (as defined in the Agreement of Merger); and

WHEREAS, eBay California is the owner of the trademarks set forth in Schedule 1 hereto (the "Trademarks"), which constitute part of the Assets; and

WHEREAS, pursuant to the Agreement of Merger, eBay Delaware desires to obtain all of eBay California's right, title and interest in, to and under said Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by eBay California, eBay California hereby sells, conveys, assigns, transfers and delivers to eBay Delaware, its successors and assigns, all of its right, title and interest throughout the world in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks, and the registrations thereof, together with the right to sue and recover damages for future infringements thereof and to stand in the place of eBay California in all matters related thereto. eBay California agrees to take such further action and to execute such additional documents as may be necessary to perfect eBay Delaware's title in and to the Trademarks.
