
THEREFORE, pursuant to the Assignment and the good and valuable consideration received thereunder, the receipt and sufficiency of which was therein acknowledged;

successors and assigns as fully and entirely as the same would have been held and enjoyed by Assignors as if the aforesaid Assignment had not been made.


