TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made and entered into by and between **PEGASUS INTERNATIONAL INC.**, a Pennsylvania corporation ("Assignor"), and **GEORGIA-PACIFIC CONSUMER PRODUCTS LP**, a Delaware limited partnership ("Assignee").

WHEREAS, Assignor is the sole and exclusive owner of the entire right, title and interest in and to the trademarks set forth on Schedule A ("Trademarks"), and the goodwill associated therewith; and

WHEREAS, Assignor wishes to assign to Assignee all right, title and interest in and to the Trademarks, together with the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee, each intending to be legally bound, hereby agree as follows:

1. Assignor does hereby sell, assign, transfer and set over to Assignee the entire right, title and interest in and to the Trademarks together with the goodwill of the business in connection with which the Trademarks are used for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the date hereof or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Trademarks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

2. Assignee shall request the Commissioner of Patents and Trademarks of the United States to record Assignee as owner of the Trademark for the sole use and enjoyment of Assignee.

3. Assignor hereby represents and warrants that it owns all right, title and interest in and to the Trademarks free and clear of any liens and encumbrances, that it has full right to assign all of its interests therein, and that it has not executed and will not execute any agreement or other instrument in conflict herewith.

4. Assignor shall provide Assignee, its successors, assigns or other legal representatives, cooperation and assistance at Assignee's request and expense (including the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens and other documentation as may be reasonably required): (ii) in the prosecution or defense of any interference, opposition, infringement or other proceedings that may arise in connection with the Trademarks, including, but not limited to, testifying as to any

facts relating to the Trademarks assigned herein and this Assignment;; and (ii) in the implementation, recordation or perfection of this Assignment.
