NUNC PRO TUNC CORRECTIVE TRADEMARK ASSIGNMENT

This Agreement is entered into by and between CLK MANAGEMENT, LLC (hereinafter "ASSIGNOR"), a corporation duly organized under the laws of the State of Kansas and having an address of P.O. Box 40394, Overland Park, Kansas 66204; and TFS Corp. (hereinafter "ASSIGNEE"), a political subdivision of the Miami Nation, a federally recognized Indian Tribe, having an address of 3531 P Street NW, P.O. Box 111, Miami, OK 74355-0111.

WHEREAS, ASSIGNOR, has adopted, used and/or licensed the use of, and is using and/or licensing the use of the mark USFASTCASH (hereinafter "the Mark"), and has filed Application Serial No. 78/428,410 (hereinafter "the Application") to register the Mark with the United States Patent and Trademark Office, the Application having been filed on June 2, 2004;

WHEREAS, ASSIGNOR executed an assignment on September 25, 2006, in connection with the Mark and the Application, and such assignment was recorded with the United States Patent and Trademark Office on September 26, 2006, at Reel 3396, Frame 0964 (the "Original Assignment");

WHEREAS, the Original Assignment inadvertently misidentified ASSIGNEE as "a corporation duly organized under the laws of the Miami Nation, a federally recognized Indian Tribe;"

WHEREAS, ASSIGNEE's correct identification is a political subdivision of the Miami Nation, a federally recognized Indian Tribe; and

WHEREAS, ASSIGNEE is desirous of acquiring all right, title and interest in, to and under the Mark and the Application.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR has sold, assigned and transferred, and by these presents does sell, assign and transfer *nunc pro tunc*, as of September 25, 2006, unto ASSIGNEE the full and exclusive right, title,

and interest, throughout the world, in, to, and under the Mark, the Application, and any and all registrations which may be granted for the Mark in the United States of America and all foreign countries thereto, together with the good will of the business symbolized by the Mark and the right to sue for and collect on all claims for damages by reason of past infringement of the Mark. At ASSIGNEE's request, ASSIGNOR shall provide non-monetary assistance to ASSIGNEE in registering, perfecting, enforcing or defending ASSIGNEE's rights in the Mark.

ASSIGNOR hereby revokes the Original Assignment dated September 25, 2006, referenced above, and requests that it be made void.
