I, Richard C. Seban, declare that:

1. I am Executive Vice President and Chief Marketing Officer of registrant corporation, and am authorized to make this declaration on behalf of said corporation.
2. I am familiar with the nature and extent of the present and past ownership of the mark.
3. Among other assignments, this registration was assigned from Interstate Brands Corporation to Interstate Brands West Corporation on October 20, 1998, and that assignment was recorded at Reel/Frame 1811/0363 on November 18, 1998.
4. Title of this registration was then transferred from Interstate Brands West Corporation to Interstate Bakeries Corporation as part of a merger dated May 30, 2004, which merger was recorded at Reel/Frame 2875/0717 on June 17, 2004.


5. There has been no change in the ownership of the mark and registration since the merger noted in paragraph 4 above, recorded at Reel/Frame 2875/0717.
