**NOTICE OF TRADEMARK SECURITY AGREEMENT**

WHEREAS, LIGHTING COMPONENTS AND DESIGN INCORPORATED, a Florida corporation (the "Grantor"), is the owner of certain trademarks, including without limitation the registrations therefor and applications in the United States Patent and Trademark Office as set forth on **Schedule A** annexed hereto and made a part hereof (collectively, the "Trademarks"); and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantor does hereby assign and grant to the Secured Party a continuing security interest in and a continuing lien on the Trademarks, as security for the payment and performance of the Obligations as defined in the Collateral Agreement.
