## INTELLECTUAL PROPERTY ASSIGNMENT

WHEREAS, Assignor additionally agrees to assign, and hereby does assign, transfer and set over to Assignee the entire right, title and interest in any and all other intellectual property it may own, including, but not limited to any and all applications for patent and any Letters Patent which may be granted therefore in the United States of America and all foreign countries, and in and to any and all divisions, continuations, continuations-in-part of said applications, or reissues or extensions of said patents or Letters Patent, and all rights under the International Convention for the Protection of Industrial Property or other intellectual property rights.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee, its successors, legal representatives and assigns, all of Assignor's right, title and interest in and to the Trademarks and any other intellectual property together with the goodwill

of the business associated with said Trademarks and registrations thereof, including any rights under common law, and which include the Trademarks alone or in combination with other words, figures, designs or indicia, including any rights, title and interest as service marks, trademarks, trade names and all common law rights connected therewith, together with the goodwill of the business with respect to which the Trademarks or any such other marks or names have been used and/or registered and all claims, proceeds and causes of action relating to past, present or future infringement of said Trademarks or said other marks or names, or other intellectual property.

Assignor hereby requests the Commissioner of Patents and Trademarks, (or applicable foreign tribunal) to record Assignee, as assignee and owner of any and all of Assignor's right in the Trademarks or other intellectual property as maybe applicable and to issue to Assignee any and all trademark registrations and service mark registrations, or other intellectual property registrations, resulting from said trademark applications and service mark applications, or any renewals of said registrations or other intellectual property applications.

Assignor agrees to execute and deliver at a future date, for no additional consideration any additional documents that the Assignee reasonably determines are required to reflect the Assignee's ownership of the Trademarks or other intellectual property anywhere in the world.

Assignor will assist in obtaining or providing any further documents which may be required to confirm chain or title thereto.

This Assignment may be signed in counterparts, each of which shall be deemed an original, but together shall constitute a single instrument.

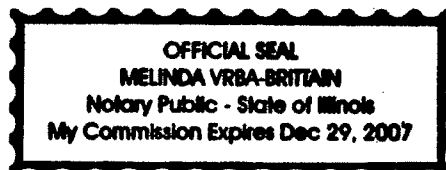

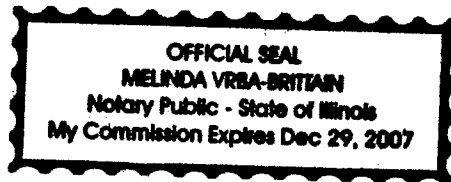
