**TRADEMARK ASSIGNMENT**

This Trademark Assignment (hereinafter referred to as "Assignment") is effective as of the 20th day of April, 2007, by and between William C. Flannery, an individual, residing at 549 East Main Street - Apt. A-16, Hendersonville, Tennessee 37075 (hereinafter referred to as "ASSIGNOR") and Mini Movie International Channel SARL, a company created and existing under the laws of Luxembourg, have a place of business at 24 Avenue Marie-Therese B.P. Luxembourg 2648L1026 (hereinafter referred to as "ASSIGNEE").

WHEREAS, ASSIGNOR has adopted, used and is using the mark MINIMOVIE (hereinafter "Mark"), for which an application was filed with the United States Patent and Trademark Office on March 27, 2007 in International Class 38 for streaming of video material on the internet with a first use anywhere date of at least as early as July 3, 2006, which application as designated Serial Number 77/140917.

WHEREAS, ASSIGNEE, and the successor to the ongoing and existing business of ASSIGNOR, or portion thereof, to which the MARK pertain, is desirous of acquiring the assets for the business, the MARK, the goodwill and business symbolized thereby, and the aforementioned trademark application therefore; and



IN WITNESS WHEREOF, the said ASSIGNOR has executed and delivered this instrument this 29th day of Nov 2007.


