## MEMORANDUM OF LICENSE

This Memorandum of License (this "Memorandum") is made effective as of the 2<sup>nd</sup> day of October, 2007 by and between AMF Bowling Worldwide, Inc., a Delaware corporation located at 8100 AMF Drive Mechanicsville, Virginia 23111 ("Licensor"), and Sportcraft, Ltd., a Delaware corporation located at 313 Waterloo Valley Road, International Trade Center, Mt. Olive, New Jersey 07828 ("Licensee").

### WHEREAS:

A. Licensor is the owner of the trademarks more particularly described on the Exhibit A attached hereto (such trademarks are herein collectively referred to as the "Trademarks").

B. This Memorandum is made and entered into as of the Effective Date in order to provide record notice of that certain Trademark License Agreement (the "Agreement") entered into as of the Effective Date between Licensor and Licensee pursuant to which Licensor has licensed the Trademarks to Licensee.

**NOW, THEREFORE**, notice is hereby given that:

1. Commencing on the Effective Date, Licensor has granted to Licensee an exclusive, perpetual, fully paid-up license to use the Trademarks throughout the world (the "Territory") in connection with the following goods and services, subject to termination by the Licensor or Licensee only pursuant to the terms of the Agreement:

Residential or commercial billiard, pool, carom, snooker or bumper pool tables, and related products and accessories for use in connection with any of the foregoing (including instructional videos and DVDs, cues, balls, table accessories, cue accessories, cue cases and cue racks); dart boards (provided they are not deemed computer games); dart board cabinets; non-computer game tables (as defined below); residential (but not commercial) game room and residential (but not commercial) outdoor furniture, including without limitation poker and pub tables, and stools and chairs for use with poker and pub tables; and the operation of wholesale distribution centers distributing only such goods and services.

As used above, "non-computer game tables" means residential or commercial table games and game table systems (including coin operated and non-coin operated table games and game table systems and parts and accessories therefore) wherein the primary elements of operation are driven manually or mechanically, involving primary physical interaction from the player, including without limitation foosball, table soccer, turbo hockey and similar table games or game tables;

2. The parties acknowledge that this Memorandum does not contain all the terms, covenants or provisions of the License, but is intended to provide notice thereof by virtue of being recorded in the United States Patent and Trademark Office and/or similar offices or authorities

throughout the Territory. The License shall control and govern with respect to any conflict between the terms or provisions herein set forth and those set forth in the License.


3. As used in this Memorandum, the terms "Licensee" and "Licensor " shall mean and include such parties and their respective successors and assigns.


