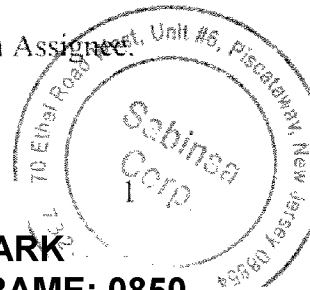

BILL OF SALE AND ASSIGNMENT

Effective as of November 26, 2007 (the "Effective Date"), SABINSA CORPORATION, a corporation organized and existing under the laws of the State of New Jersey, having its principal office at 70 Ethel Road West Unit #6, Piscataway NJ 08854 (hereinafter referred to as "Assignor"), for and in consideration of the sum of twenty thousand dollars (\$20,000.00), hereby sells, assigns and transfers to WILLIAM F. HENRI, ESQ. a citizen of Texas, residing at 6633 Mercer, Houston, Texas 77005 as Agent (hereinafter referred to as "Assignee") for an undisclosed Principal having intent to acquire Assignor's trademark "BIO-Q10, whatsoever right, title and interest throughout the world, it has or may have, if any, in and to the designation BIO-Q10 used as a trademark for all goods and services of any kind or nature whatsoever, including but not limited to nutritional supplements and absorption enhancers as a component thereof (hereinafter the "BIO-Q10 trademark"), together with the related goodwill of the business, if any, symbolized thereby and associated therewith, and all applications and registrations, if any, for the BIO-Q10 trademark.

The parties have further executed a Quitclaim Assignment of the BIO-Q10 trademark annexed hereto as Exhibit A and it is understood and agreed that Assignor will cooperate in executing any further documents necessary for recordation in any governmental office or agency and/or to otherwise give effect to the purpose of this Bill of Sale and Assignment; and any associated costs shall be paid by Assignee.

It is further understood and agreed that State Bank of India ,bankers for Assignor shall hold in escrow the fully executed Bill of Sale and Assignment and Quitclaim Assignment pending payment of the sum of twenty thousand dollars (\$20,000.00) to Assignor from Assignee.

Assignor represents and warrants to Assignee that Assignor owns the BIO-Q10 trademark, which has been in use in interstate commerce in the United States since at least as early as 1996; that the BIO-Q10 trademark is free and clear of all liens, security agreements and claims and is not known to infringe upon the rights of any third party; and that Assignor has the authority to sell the BIO-Q10 trademark and to make this Bill of Sale and Assignment.

Assignor has caused this Bill of Sale and Assignment to be ratified by its proper corporate officer and its corporate seal to be affixed on November 26, 2007.

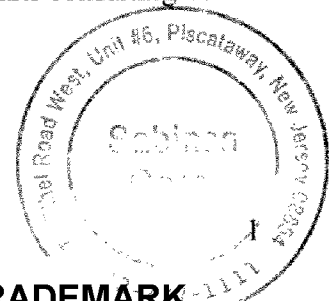
QUITCLAIM ASSIGNMENT

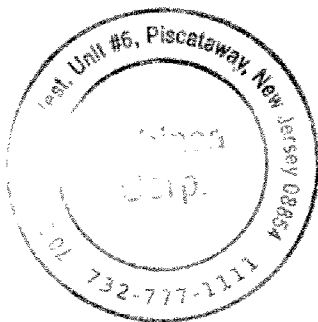
