
**RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

**WHEREAS**, DJ ORTHOPEDICS DEVELOPMENT CORPORATION and AIRCAST LLC (each a "Pledgor," and collectively known as the "Pledgors") are the owners of the trademarks and service marks listed on Schedule A attached hereto, which marks are registered or have pending registrations in the United States Patent and Trademark Office as set forth on Schedule A attached hereto (all such trademarks, service marks, registrations and applications, collectively, the "Trademarks");

**WHEREAS**, in order to secure certain indebtedness, the Pledgors entered into a Security Agreement (as amended, modified, restated or supplemented from time to time, the "Security Agreement"), dated as of June 30, 1999, November 26, 2003, May 5, 2005 and April 6, 2006, in favor of Wachovia Bank, National Association (f/k/a First Union National Bank), as Administrative Agent (the "Administrative Agent"), with offices at One Wachovia Center, 301 South College Street, Charlotte, North Carolina 28288-0755, and pursuant thereto executed and delivered a Grant of Security Interest in Trademarks (the "Trademark Assignments") as recorded in the United States Patent and Trademark Office in Reel 2878, Frame 0185; Reel 2878, Frame 0986; Reel 2689, Frame 0062; Reel 2658, Frame 0950; Reel, 2910, Frame 0067; Reel 2913, Frame 0105; Reel 003128, Frame 0483; Reel 3309, Frame 180; and Reel 3309, Frame 208, pursuant to which the Pledgors granted to the Administrative Agent, according to the terms of the Security Agreement, a security interest in all of its right, title and interest in and to the Trademarks;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby release and relinquish, and does hereby reassign to the Pledgors, or their successors or assigns, as applicable, without representation or warranty, all of the Administrative Agent's right, title and interest in and to the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Trademark Assignments in the United States Patent and Trademark Office as aforesaid may be removed of record.
