Assignment 1

1 Trademark Assignment

WHEREAS, Symantec Corporation, a Delaware corporation with its principal place of business of 20330 Stevens Creek Boulevard, Cupertino CA 95014, United States of America (hereinafter "Assignor"), is owner of all right, title and interest in and to the trademarks, service marks, and registrations, applications and/or uses, including common law rights in territories where such rights are recognized and the goodwill of the business associated therewith, as detailed in the attached Exhibit titled "Assigned Marks" (collectively the "Marks").

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby irrevocably acknowledged, Assignor hereby assigns, sells, conveys, and transfers to Assignee, its successors and assigns, any and all of its rights, title and interest in and to the Marks, and the applications and registrations therefor, together with the goodwill of the business symbolized by the Marks and uses thereof, including, without limitation the exclusive rights to (a) apply for and maintain all registrations, renewals and/or extensions thereof, (b) bring actions and recover damages for past, present and future infringement thereof, (c) grant licenses or other interests therein and (d) otherwise fully and entirely stand in the place of Assignor in all matters related thereto.

The Assignor hereby authorizes and requests the Commissioner for Trademarks of the United States and the competent authorities in other territories with jurisdiction over the registrations and applications for the Marks to issue, record, and memorialize this Trademark Assignment with regard to any and all pending applications and registrations for the Marks.
