SECURITY INTEREST  
IN UNITED STATES TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, WGU, LLC, a Texas limited liability company (the "Assignor") with principal offices at 2801 East Plano Parkway, Plano, Texas 75074, hereby grants to Wachovia Bank, National Association, as Bank, with principal offices at 5001 LBJ Freeway, Suite 1050, Dallas, Texas, 75244 (the "Assignee"), a security interest in (i) all of the Assignor's right, title and interest in and to the United States trademarks, including all trademark registrations (the "Marks") set forth on Schedule A attached hereto, together with (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS SECURITY INTEREST is made to secure the satisfactory performance and payment of all of the Assignor's Obligations, as such term is defined in the Loan and Security Agreement among the Assignor, the other assignors from time to time party thereto and the Assignee, dated as of November 13, 2007 (as amended from time to time, the "Security Agreement"). Upon the occurrence of the effective date of termination of the Financing Agreements (as defined in the Security Agreement), the Assignee shall, upon such satisfaction, execute, acknowledge, and deliver to the Assignor an instrument in writing releasing the security interest in the Marks acquired under this Agreement.

This security interest has been granted in conjunction with the security interest granted to the Assignee under the Security Agreement. The rights and remedies of the Assignee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated

herein by reference. In the event that any provisions of this Agreement are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.


