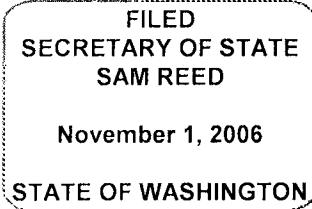

ARTICLES OF AMENDMENT
OF
JET CITY JET, INC.

Pursuant to RCW 23B.10.060, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Jet City Jet, Inc. (the "Corporation").

SECOND: The amendments to the Articles of Incorporation as adopted are as follows:

Article I of the Articles of Incorporation is hereby amended in its entirety to read as follows:

"ARTICLE I

NAME

The name of the corporation is Limeade, Inc. (the "Corporation")."

THIRD: The amendment does not provide for an exchange, reclassification, or cancellation of issued shares.

FOURTH: The foregoing amendment was adopted by the board of directors of the Corporation on October 30, 2006.
