The entry in the commercial register of the Oberhausen district court was effected on 19 March 1999.

At the same time I hereby certify according to my inspection of the HRB 67 commercial register file of the Oberhausen district court which now is available in the commercial register of the Duisburg district court that Babcock Borsig Aktiengesellschaft, Duisburger Str. 375, 46049 Oberhausen registered so far at said court, as transferring company was merged according to the merger agreement dated 28 May 2001 with BDAG Balcke-Dürr AG, Homberger Str. 2, 40882 Ratingen – HRB 50 of the Ratingen district court – as equally transferring company according to article 2 No. 2 of the German conversion act by establishment of the new Babcock Borsig AG, Duisburger Str. 375, 46049 Oberhausen with registered office in Oberhausen while the annual shareholders' meetings of the former Babcock Borsig Aktiengesellschaft agreed to the merger agreement on 18 May 2001 and that of BDAG Balcke Dürr AG on 25 May 2001.

The merger became effective on 12 July 2001 with the entry of the new entity – Babcock Borsig AG, Duisburger Str. 375, 46049 Oberhausen – in the commercial register of the Oberhausen district court under HRB 3816, now entered in the commercial register of the Duisburg district court under HRB 13564.
