**TRADEMARK ASSIGNMENT**

This Trademark Assignment is effective as of March 30, 2007, is made by Desmond Van Allen, a U.S. citizen (hereinafter "ASSIGNOR"), to TimeLine Recruiting, LLC, a Missouri limited liability company (hereinafter "ASSIGNEE").

WHEREAS, ASSIGNOR is the owner of the common law rights in the mark **TIMELINE RECRUITING®** (hereinafter the "Mark") by virtue of its use of the mark in commerce in connection with Professional healthcare recruitment and placement services on behalf of hospitals and clinics;

WHEREAS, ASSIGNOR has received federal registration of the mark with the United States Patent and Trademark Office ("USPTO") and such registration has been designated as U.S. Reg. No. 2,588,604;

WHEREAS, ASSIGNEE has agreed to acquire any and all rights that ASSIGNOR possesses in the Mark including the USPTO Registration, together with the goodwill of the business in connection with which the Mark is being used, and which is symbolized by the Mark, along with the right to recover damages and profits for past infringements thereof; and

WHEREAS, ASSIGNEE has under a separate agreement, undertaken to transfer its business assets, including the Mark and all good will associated therewith, to Maxim Healthcare Services, Inc., a Maryland corporation, for valuable consideration;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, ASSIGNOR hereby assigns to ASSIGNEE all right, title and interest in and to the Mark (and all Registrations and Applications filed in connection therewith) in the United States and throughout the entire world, together with (a) the goodwill of the business in connection with which the Mark is used and which is symbolized by the Mark; and (b) the right to recover for damages and profits for past infringements thereof;

ASSIGNOR agrees to execute and deliver at the request of the ASSIGNEE, all papers, instruments, and assignments, and to perform any other reasonable acts the ASSIGNEE may require in order to vest all ASSIGNOR's rights title and interest in and to the Mark in the ASSIGNEE and to supply evidence to support any of the foregoing in the event such evidence is in ASSIGNOR's possession and such evidence is required by ASSIGNEE.
