TRADEMARKS

This RELEASE OF SECURITY INTEREST is dated and effective as of the 5th day of May, 2006, and is made by and between MERRILL LYNCH CAPITAL, A DIVISION OF MERRILL LYNCH BUSINESS FINANCIAL SERVICES INC., (AS FIRST LIEN COLLATERAL AGENT) ("Grantee"), in favor of ACI BILLING SERVICES, INC., HBS BILLING SERVICES COMPANY, BILLING CONCEPTS, INC. and ENHANCED SERVICES BILLING, INC. (each a "Grantor" and collectively, the "Grantors").

WITNESSETH:

WHEREAS, on or about April 27, 2005, Grantors granted to Grantee a lien on and security interest in certain intellectual property rights of Grantors, including, but not limited to, Grantors' trademark properties as more particularly described in Appendix A attached hereto and certain related rights, interests and assets; and

WHEREAS, the aforementioned security interest was reflected in a duly executed document entitled "First Lien Pledge and Security Agreement," which was recorded in the records of the Assignment Division of the United States Patent and Trademark Office on or about May 1, 2005 at reel/frame 3076/0059, reel/frame 3075/0930 and reel/frame 3076/0001; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:




