**RELEASE OF SECURITY INTEREST**  
**TRADEMARKS**

This RELEASE OF SECURITY INTEREST is dated and effective as of the 5<sup>th</sup> day of May, 2006, and is made by and between GOLDMAN SACHS CREDIT PARTNERS L.P., (AS SECOND LIEN COLLATERAL AGENT) ("Grantee"), in favor of ACI BILLING SERVICES, INC., HBS BILLING SERVICES COMPANY, BILLING CONCEPTS, INC. and ENHANCED SERVICES BILLING, INC. (each a "Grantor" and collectively, the "Grantors").

**W I T N E S S E T H:**

WHEREAS, on or about April 27, 2005, Grantors granted to Grantee a lien on and security interest in certain intellectual property rights of Grantors, including, but not limited to, Grantors' trademark properties as more particularly described in Appendix A attached hereto and certain related rights, interests and assets; and

WHEREAS, the aforementioned security interest was reflected in a duly executed document entitled "Second Lien Pledge and Security Agreement," which was recorded in the records of the Assignment Division of the United States Patent and Trademark Office on or about May 1, 2005, at reel/frame 3076/0245, reel/frame 3076/0117 and reel/frame 3076/0185; and

which rights and interests specifically include, without limitation, the trademark properties as more particularly described in Appendix A.


