1. He is the duly elected and acting President and Chief Executive Officer of ZenZui, Inc., a Delaware corporation.

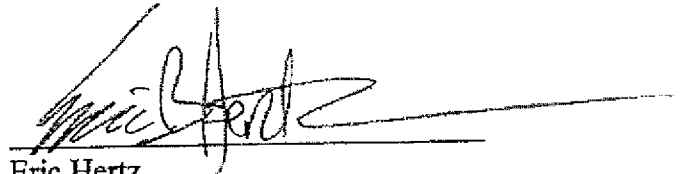
