INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT, dated as of September 23, 2003.

WHEREAS, CDI-TVC Finance, Inc., f/k/a TVC Communications, Inc., a Delaware corporation, having its principal place of business at 800 Airport Road, Annville, Pennsylvania 17003 (the "Assignor") and Power & Telephone Supply Company, a Tennessee corporation, having its principal place of business at 2673 Yale Avenue, Memphis, Tennessee 38112 ("P&T"), are parties to that certain Asset Purchase Agreement (the "Purchase Agreement"), dated as of September 5, 2003;

WHEREAS, effective September 16, 2003, P&T assigned its rights (but not its obligations) under the Purchase Agreement to Power & Telephone – Clifford Company, a Tennessee corporation ("Assignee"); and

WHEREAS, Marc Talon, Inc., a California corporation and an affiliated company of Assignor ("Talon"), is the registered owner of the trademark set forth on the attached Schedule A (the "Trademark").

NOW, THEREFORE, as a condition precedent to the consummation of the transactions contemplated under the Purchase Agreement, for \$10.00 cash in hand, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

(1) the Assignor and Talon, have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the Assignee, its successors, legal representatives and assigns, their entire right, title and interest in, to and under the Trademark, together with the good will of the business appurtenant thereto and symbolized by said Trademark, and

(2) the Assignor and Talon authorize and request the Commissioner of the United States Patent and Trademark Office ("USPTO") and any official of any country or countries foreign to the United States ("Foreign Offices"), whose duty is to issue trademark registrations on applications as aforesaid, to issue the same to the Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument, and

(3) Assignor and Talon covenant and agree that, after the date of this Assignment, Assignor and Talon will provide Assignee with any further deeds of assignment or other documents reasonably required to complete the transfer of title therein to Assignee, in form suitable for recordation in the USPTO or applicable Foreign Offices.
