

Assignor hereby requests the United States Commissioner of Patents and Trademarks and the corresponding government officer in the Japan Patent Office to record Assignee as the assignee and owner of the Marks. It being understood, however, that Assignor is not responsible for the recordation of the assignment in any trademark office.
