TRADEMARK ASSIGNMENT

NOW, THEREFORE, in consideration of the payment of good and valuable consideration of at least one (1) dollar, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, and assigns to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Marks, together with: (1) the goodwill of the business and services symbolized by the Trademarks and for which they are registered; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Trademarks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Trademarks; and (3) all rights to sue for past, present and future infringements or misappropriations of the Trademarks.

ASSIGNOR hereby warrants that it is the rightful owner all right, title and interest in and to the Trademarks free and clear of any encumbrances, liens, mortgages, security interests, and the like and has the unconditional right to convey such right, title and interest to ASSIGNEE.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Trademarks.

This Agreement may be executed in one or more counterparts, each which will be deemed an original, but all of which together will constitute one in the same instrument.

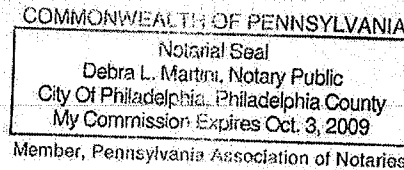
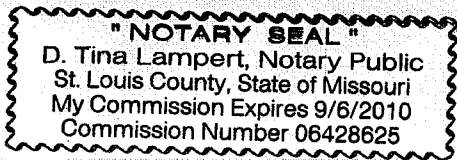
