RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of December 10, 2007 ("Effective Date") by **GENEALOGY.COM, LLC**, a Delaware limited liability company, with an address at c/o A&E Television Networks, 235 East 45th Street, New York, New York 10017 ("Secured Party") in favor of **THE GENERATIONS NETWORK, INC.** (f/k/a MYFAMILY.COM, INC.), a Delaware corporation, with its principal office at 360 W. 4800 N., Provo, Utah 84604 ("Debtor").

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement by and between Debtor and Secured Party dated April 4, 2003 (the "Security Agreement"), Debtor granted to Secured Party a continuing security interest in and to all of Debtor's right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing (collectively, the "Trademarks"), including, without limitation, the United States trademark registrations and applications for trademark registration set forth on Schedule A attached hereto, together with the goodwill associated therewith;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on June 10, 2003, at Reel 2666, Frame 0226; and

WHEREAS, Debtor has paid all of its outstanding indebtedness to Secured Party.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Secured Party represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, other than those Trademarks set forth on Schedules A (attached hereto), in any jurisdiction throughout the world other than such filings made in the United States Patent and Trademark Office.

Secured Party shall, at Debtor's expense, take all further actions, and provide to Debtor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Debtor to more fully and effectively effectuate the purposes of this Release.
