WHEREAS, Georgina Chapman ("Chapman") and Keren Craig ("Craig" and collectively with Marchesa and Chapman, "Assignors"), individually or jointly, own, may be deemed to own, or have created, designed, sketched, produced, manufactured or had manufactured, certain clothes or items that have been marketed or sold by Marchesa, and are not set forth on Schedule A, and all related intellectual property rights thereto (the "Other Intellectual Property" and collectively with the Marchesa Intellectual Property, the "Intellectual Property"); and

WHEREAS, MARCHESA HOLDINGS, LLC, a Delaware Limited Liability Company, having an address of 413 West 14th Street, Suite 403, New York, New York 10014 ("Assignee"), is desirous of acquiring the Intellectual Property and the goodwill associated therewith, all incident to the transfer to Assignee of the business associated therewith;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors hereby assign, convey, transfer, deliver, set over and vest to and in Assignee, its successors and assigns, irrevocably, absolutely and forever, all right, title and interest, in and to all the Intellectual Property owned by Assignors, including U.S. and foreign trademark registrations, applications and renewals set forth on Schedule A annexed hereto and made a part hereof, and all trade names, trade secrets, copyrights, domain names, letters patent and applications for letters patent, including all divisionals and re-issues; design patents, source code, software, and all other means necessary to use such property in connection with the business of Assignors and the Intellectual Property. Assignors hereby further assign, convey, transfer, deliver, set over and vest all of Marchesa's goodwill in its business and all income, royalties, damages and

payments now or hereafter due or payable in respect to the Intellectual Property, and all causes of action (either in law or in equity) and the right to sue, counterclaim and recover for past, present and future infringement of the Intellectual Property and the rights thereto.



Until such time as all of the Assignments of Assignors' Intellectual Property as set forth in the annexed Schedule A are duly recorded with the United States Patent and Trademark Office and the appropriate foreign trademark offices (the "Interim Period"), Assignors acknowledge and confirm that Assignee shall, in any event, be deemed hereunder and in accordance with the terms and conditions of this Assignment, to be the owner of Assignor's Intellectual Property and to take all action necessary to maintain and enforce such rights.

This Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.
