NOW, THEREFORE, effective as of December 14, 2007, Deja transfers unto BARHC, its successors and assigns, all of Deja's right, title and interest in and to the Marks, together with the goodwill symbolized by the Marks, and any and all claims and demands at law or in equity that Deja now has or may hereafter acquire on account of any infringement of the Marks prior to the effective date hereof.
