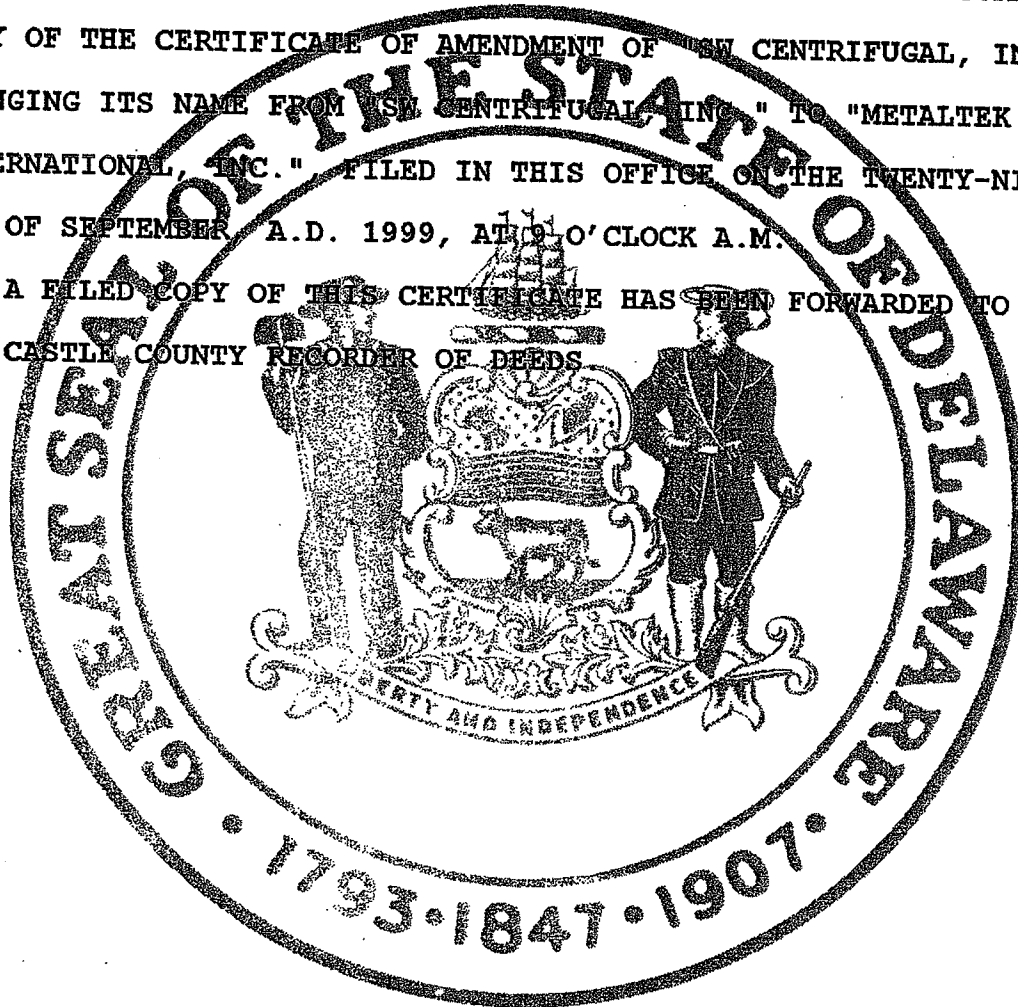

**CERTIFICATE OF AMENDMENT**

TO

**CERTIFICATE OF INCORPORATION**

OF

**SW CENTRIFUGAL, INC.**

SW Centrifugal, Inc. (the "Company"), for the purpose of amending the Certificate of Incorporation filed with the office of the Secretary of State of Delaware on May 28, 1980 (under the Company's previous name of "Anaconda Wisconsin, Inc."), as such Certificate of Incorporation has been previously amended by (i) the Certificate of Merger filed with the office of the Secretary of State of Delaware on August 13, 1980 (pursuant to which Wisconsin Centrifugal, Inc., a Wisconsin corporation, was merged into the Company), (ii) the Certificate of Correction to Certificate of Merger filed with the office of the Secretary of State of Delaware on October 7, 1980 (pursuant to which the Company's name was changed to Wisconsin Centrifugal, Incorporated), (iii) the Certificate of Merger filed with the office of the Secretary of State of Delaware on June 7, 1985 (pursuant to which Southern Acquisition Company, a Delaware corporation, was merged into the Company) and (iv) the Certificate of Merger filed with the office of the Secretary of State of Delaware on January 11, 1989 (pursuant to which Southern Centrifugal, Incorporated, a Tennessee corporation, was merged into the Company and the name of the Company was changed to SW Centrifugal, Inc.), hereby certifies that:

1. The name of the Company is SW Centrifugal, Inc.
2. The Certificate of Incorporation of the Company is hereby amended to delete Article 1 in its entirety and to substitute the following in its place:

"1. The name of the corporation is:

**MetalTek International, Inc."**

3. The foregoing amendment to the Certificate of Incorporation has been duly adopted in accordance with Section 242 of the Delaware General Corporation Law.
