ASSIGNOR further covenants that ASSIGNEE, upon request, will be provided with all documents and instruments in the possession or control of ASSIGNOR as may be reasonably

required to evidence or effectuate the conveyance, assignment, transfer and delivery to the ASSIGNOR of The Trademarks.

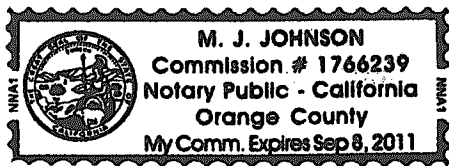
