COLLATERAL ASSIGNMENT OF TRADEMARKS AND SERVICE MARKS (U.S.)

This Collateral Assignment of Trademarks and Service Marks (U.S.) is intended to and shall take effect as a sealed instrument at such time as the Assignee shall complete this instrument by inserting its name in the second paragraph above and signing its acceptance of this Assignment of Trademarks and Service Marks (U.S.) below.

This agreement should be interpreted in conjunction with the Security and Pledge Agreement dated December 11, 2007 entered into among the parties hereto and the other parties thereto, the terms of which are incorporated into this agreement mutatis mutandis.


