TRADE MARK ASSIGNMENT (U.S.)

This Assignment is dated 7th day of March 2006

BETWEEN

- (1) **MARCIA KILGORE** of First Floor, 56 Queens Gate, South Kensington, SW7 5JW, London, United Kingdom ("**Assignor**"); and
- (2) **BRANDHANDLING INTERNATIONAL LIMITED** a company registered in the British Virgin Isles with company number 1002162, whose registered office is at Suite 6S, Mill Mall, Wickhams Cay 1, Road Town, Tortola, British Virgin Islands ("**Assignee**").

BACKGROUND

- (A) The Assignor is the proprietor of the trade marks registered or the subject of applications for registration in the United States of America listed in the Schedule ("**Trade Marks**").
- (B) The Assignor has agreed to assign all its rights in and to the Trade Marks to the Assignee on the terms set out below.

AGREED TERMS

1. ASSIGNMENT

In consideration of the sum of £1 exclusive of value added tax paid by the Assignee to the Assignor (receipt of which the Assignor hereby acknowledges), the Assignor hereby assigns to the Assignee absolutely:

- (i) the Trade Marks and all and any rights in and to the Trade Marks;
- (ii) including the benefit of the applications for registration with the intention that, when the applications are granted the registrations shall vest in the Assignee; and
- (iii) any common law rights, unregistered rights and all the goodwill attaching to the Trade Marks.

2. PROCEEDINGS

- 2.1 This assignment shall include the right for the Assignee to bring proceedings against any third party in respect of the Trade Marks (including proceedings against any third party for infringement of the Trade Marks or for passing off or for otherwise infringing the rights of the Assignor in the Trade Marks).
- 2.2 The Assignor agrees and undertakes to provide the Assignee (at its request) with all such assistance with any proceedings which may be brought by or against the Assignee against or by any third party in relation to the Trade Marks.

3. **FURTHER ASSURANCE**

The Assignor shall at the cost and expense of the Assignee do or procure to be done all such further acts and things, and execute or procure the execution of all such other documents, as the Assignee may from time to time reasonably require in order to give the Assignee the full benefit of this agreement.

4. **GOVERNING LAW AND JURISDICTION**

4.1 Subject to clause 4.2 this agreement shall be governed by and construed in accordance with the law of England and Wales, and each party irrevocably agrees to submit to the exclusive jurisdiction of the courts of England and Wales over any claim or matter arising under or in connection with this agreement.

4.2 The parties agree to submit to the appropriate federal or national laws and/or courts of the United States of America or a particular State where this is necessary to give best effect to this Assignment.


