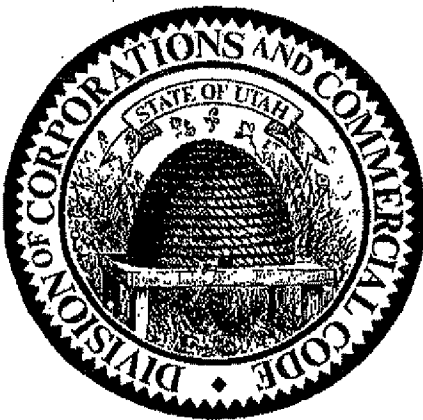

ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF

OSMOND FOUNDATION, FOR THE CHILDREN OF THE WORLD

Pursuant to Section 1005 of the Utah Revised Nonprofit Corporation Act, Osmond Foundation, for the Children of the World (the "Corporation") hereby submits the following Articles of Amendment to its Articles of Incorporation, as previously amended (the "Articles of Incorporation").

FIRST:

The name of the Corporation, prior to the filing of these Articles of Amendment, has been OSMOND FOUNDATION, FOR THE CHILDREN OF THE WORLD.

SECOND:

Article I of the Corporation's Articles of Incorporation is hereby amended to read in its entirety as follows:

ARTICLE I

The name of this corporation is Children's Miracle Network.


THIRD:

The foregoing Articles of Amendment were adopted at a duly noticed meeting of the Board of Trustees of the Corporation held April 2, 2007 at 8:00 a.m. in Orlando, Florida.
