UNDER ARTICLE 5.18 OF
THE TEXAS BUSINESS
CORPORATION ACT

ICO Worldwide, Inc. (the "**Company**"), a corporation organized and existing under and by virtue of the Texas Business Corporation Act (the "**Act**"), DOES HEREBY CERTIFY THAT:

FIRST: The name of the Company is ICO Worldwide, Inc. and the Company is a corporation incorporated under the laws of the State of Texas.

SECOND: In accordance with Article 5.17 of the Act, the shareholders of the Company unanimously approved, by written consent in accordance with Article 9.10A of the Act, a Plan of Conversion (the "**Plan**") whereby the Company would convert into ICO Worldwide, L.P., a Texas limited partnership (the "**Partnership**").

THIRD: An executed copy of the Plan is on file at 5333 Westheimer, Suite 600, Houston, Texas 77056, the principal place of business of the Company, and from and after the conversion such executed copy of the Plan will be on file at 5333 Westheimer, Suite 600, Houston, Texas 77056, the principal place of business of the Partnership.

FOURTH: A copy of the Plan will be furnished by the Company prior to the conversion or by the Partnership after the conversion, on written request and without cost, to any shareholder of the Company or partner of the Partnership.

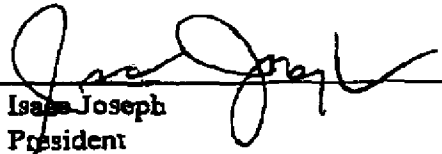
FIFTH: The number of outstanding shares of capital stock of the Company is 1,000, all of which are entitled to vote as a single class.

SIXTH: The Partnership will be responsible for the payment of all fees and franchise taxes now or hereinafter due or owing by law on behalf of the Company or the Partnership and shall pay such in a timely manner.

SEVENTH: These Articles of Conversion shall become effective as of 9:00 p.m. CDT on September 5, 2002.

**CERTIFICATE OF LIMITED PARTNERSHIP

This Certificate of Limited Partnership dated August 29, 2002 has been duly executed and is filed pursuant to Section 2.01 of the Texas Revised Limited Partnership Act (the "Act") to form a limited partnership under the Act.
