3. This Amendment was adopted by the affirmative consent of the members of the Company as required by Section 183.0404(2) of the Wisconsin Statutes.

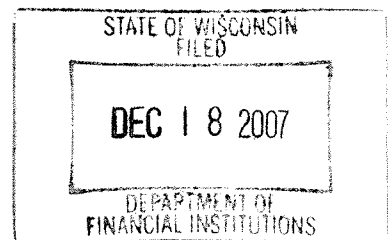
