**RELEASE OF TRADEMARK SECURITY AGREEMENT
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of September 28, 2007, is made by Ableco Finance LLC, a Delaware limited liability company ("Ableco"), as collateral agent for the below-defined Lenders pursuant to the below-defined Financing Agreement (in such capacity, "Collateral Agent"), in favor of Progressive Gaming International Corporation, Mikohn Nevada, MGC, Inc., Progressive Games, Inc., Mikohn International, Inc., Viking Merger Subsidiary, LLC, Primeline Gaming Technologies, Inc. & Games of Nevada, Inc. as follows:

WITNESSETH

WHEREAS, reference is made to that certain Amended and Restated Financing Agreement dated as of August 4, 2006 among Progressive Gaming International Corporation, a Nevada corporation ("Borrower"), each Subsidiary of the Borrower listed as a "Guarantor" on the signature pages thereto (each a "Guarantor" and collectively, jointly and severally, the "Guarantors"), the Lenders from time to time party thereto ("Lenders"), Collateral Agent, and Ableco, as administrative agent for the Lenders (in such capacity, together with any successor administrative agent, the "Administrative Agent" and together with the Collateral Agent, each an "Agent" and collectively, the "Agents") (as amended, restated, supplemented or otherwise modified from time to time, the "Financing Agreement"). Capitalized terms used herein without definition shall have the meanings ascribed thereto in the Financing Agreement.

WHEREAS, pursuant to (a) the Amendment Number Two to Trademark Security Agreement dated February 17, 2007 and recorded with The United States Patent and Trademark Office on February 22, 2007 at Reel/Frame No. 3485/0969, and (b) the Trademark Security Agreement dated April 20, 2006 and recorded with The United States Patent and Trademark Office on April 27, 2006 at Reel/Frame No. 3298/0199, certain of the Loan Parties granted to the Collateral Agent, a security interest in certain of their trademarks and all applications and registrations therefor; and

WHEREAS, the Loan Parties have requested that the Collateral Agent release its security interest in and to trademarks, and all applications and registrations therefor, set forth in Schedule A hereto (the "Released Trademark Collateral").

NOW, THEREFORE, the Collateral Agent, without recourse, representation or warranty and at the Loan Parties' sole cost and expense, hereby RELEASES its security interest in and to the Released Trademark Collateral set forth on Schedule A hereto. The Collateral Agent hereby agrees to take such further actions and to execute and deliver such further documents as the Loan Parties may reasonably request, and at the Loan Parties' sole cost and expense, to effect and evidence the Collateral Agent's release of its security interest in and to the Released Trademark Collateral.
