## RELEASE OF SECURITY INTERESTS TRADEMARKS

This RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is dated as of December 6, 2007 by Comerica Bank, a Michigan banking corporation ("Bank"), pursuant to that certain Credit Agreement dated as of March 16, 2006 (as amended, modified, supplemented, extended, renewed, restated or replaced, the "Credit Agreement") in favor of International Graphics Inc., R Tape Corporation and Custom Extrusion Technologies, Inc. (collectively, "Debtors").

WHEREAS, in connection with the Credit Agreement, the Debtors executed and delivered that certain Security and Pledge Agreement dated as of March 16, 2006 (the "Security Agreement");

WHEREAS, as a condition to the Credit Agreement and the Security Agreement, the Debtors executed and delivered that certain Agreement (Trademark) dated as of March 16, 2006 (the "Trademark Security Agreement") pursuant to which Debtors mortgaged, pledged and hypothecated to Bank, and granted to Bank a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank and Debtors hereby agrees as follows:

1. Release. Bank hereby releases and relinquishes the mortgage, pledge and hypothecation, and releases and relinquishes the security interest in, the Trademark Collateral, including but not limited to the Trademark Collateral set forth in Schedule A attached hereto, in each case, granted to Bank pursuant to the Security Agreement and the Trademark Security Agreement.

2. Miscellaneous.

(a) This Release is without representation, warranty or recourse of any kind, nature or description. This Release shall be binding upon Bank's legal representatives, assigns and successors.


(b) This Agreement represents the parties' entire agreement and understanding with respect to the matters set forth herein and no amendment or modification to the terms and conditions of this Agreement shall be made except by a writing signed by each of the parties. This Agreement supersedes all prior agreements and understandings between the parties with respect to the subject matter hereof.

(c) This Agreement shall be governed by, and construed in accordance with, the internal laws of the State of Michigan.

(d) This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
