## TRADEMARK ASSIGNMENT

WHEREAS, Universal Automotive, Inc., a corporation of Illinois and/or Universal Automotive Industries, Inc., a Delaware corporation (collectively, "Assignors"), each having a principal place of business at 11859 South Central Avenue, Alsip, Illinois 60803 own the following trademarks, registered with the United States of America Patent & Trademark Office or applied for (collectively, the "Trademarks"):

1. U.S. Trademark Registration No. 74582784 issued December 26, 1995 for the mark "AUTOSPECIALTY."
2. U.S. Trademark No. 2194759 issued October 13, 1998 for the mark "POWER STOP."
3. Trademark Application filed April 29, 2005 for the trademark Power Stop.

WHEREAS, Assignors have sought protection from the US Bankruptcy Court, District of New Jersey ("Court") under Chapter 11, Case No. 05-27778. In RE: Universal Automotive Industries, Inc., Universal Automotive, Inc., Universal Automotive of Virginia, Inc.; Universal Brake Parts, Inc.; and The Automotive Commodity Connection, Inc. (collectively, the "Debtors").

WHEREAS, the Court has appointed Hilco Wholesale, LLC ("Hilco") with full authority to sell the inventory and trademarks of each of the Debtors and the Assignee has agreed to purchase the Trademarks from Assignor on behalf of the Estate of the Debtors. Hilco has authorized David Blakely to execute this assignment on behalf of Assignor.

WHEREAS, Power Stop, LLC, an Illinois limited liability company ("Assignee"), has agreed with Assignor and Hilco to purchase the Trademarks for cash and has tendered the full purchase price consideration therefore.

NOW THEREFORE, for and in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, said Assignors, have sold, assigned and set over, and by these presents do hereby sell, assign and set over unto the said Assignee, its legal representatives, successors and assigns, their entire rights, title and interest, free and clear from all liens and encumbrances in and to each and every one of the Trademarks and all goodwill associated with each of the Trademarks and the right to use each of the trademarks Autospecialty and Power Stop in connection with the automotive business, including but not limited to the sale of brake parts and apparel. Assignors authorize Assignee to lodge with the U.S. Patent and Trademark Office this Assignment, as well as evidence of the original assignment to either or both of Assignors of the Trademarks from Kelsey-Hayes Company to one of Assignors in 2004.


