

GRANT OF FIRST LIEN SECURITY INTEREST

WHEREAS, AHC MEDIA LLC, a Delaware limited liability company ("AHC"), has adopted, used and is using the trademarks described on Schedule A (the "Trademarks");

WHEREAS, AHC is a party to a Second Amended and Restated Security Agreement dated July 6, 2007 (as the same may be amended, restated, modified, and/or supplemented from time to time, the "Agreement") in favor of NATIONAL CITY BANK as Agent for itself and other Secured Parties referred to in the Agreement (in such capacity, with its successors and assigns hereinafter referred to as "Agent"); and

WHEREAS, pursuant to the Agreement, AHC granted to Agent (for the benefit of the Secured Parties) a security interest in all right, title and interest of AHC in and to, among other things, the Trademarks, together with all goodwill associated therewith, all applications and/or registrations pertaining thereto, and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations, as that term is defined in the Amended and Restated Credit Agreement, dated as of the date of the Agreement (as amended, restated, modified and/or supplemented from time to time, the "Credit Agreement").

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, AHC does hereby grant to Agent a security interest in the Collateral to secure the prompt payment, performance and observance of its obligations, including without limitation the Secured Obligations. The security interest granted hereby is senior to the lien granted in connection with that certain Second Lien Security Agreement dated as of July 6, 2007 and that certain Grant of Second Lien Security Interest dated on or about the date hereof (as the same may be amended, restated, modified, and/or supplemented from time to time) in favor of National City Bank, as agent for itself and other Secured Parties in connection with the Amended and Restated Second Lien Credit Agreement dated as of July 17, 2007 (as amended, restated, modified and/or supplemented from time to time), pursuant to a certain intercreditor agreement between the Agent in connection with the lien evidenced hereby and the agent for the lenders under the Amended and Restated Second Lien Credit Agreement, as such intercreditor agreement may be amended, restated, modified and/or supplemented from time to time.

AHC does hereby further acknowledge and affirm that the rights and remedies of Agent with respect to the security interest in the Collateral made and granted hereby are fully set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
