TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, CROWN CASTLE INTERNATIONAL CORP., a Delaware corporation ("Assignor"), owns and has used in business certain trademarks which are set forth on Schedule A attached hereto, together with goodwill of the business symbolized thereby and associated therewith, as well as the Trademark Registrations which have already issued ("Marks"); and

WHEREAS, CROWN CASTLE INVESTMENT CORP., a Delaware corporation ("Assignee"), desires to acquire, and Assignor desires to transfer to Assignee, all of the right, title, and interest of Assignor in and to the Marks, and in and to any renewals and extensions that may be granted thereon, together with goodwill of the business connected therewith, subject to the License (defined below);

NOW, THEREFORE, BE IT KNOWN that in consideration of the mutual covenants and undertakings contained herein, and for other good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

1. Assignor does hereby assign, transfer and convey to Assignee all of its right, title and interest in and to the Marks, inclusive of goodwill of the business symbolized by the Marks, including the right to use the Marks in Assignee's trade names and corporate names, and the right to sue for and be entitled to any damages for infringement of the Marks, effective as of the effective date shown below; provided such is subject to the License.

2. Assignee hereby accepts the assignment of the Marks, inclusive of goodwill of the business symbolized by the Marks, including the right to use the Marks in Assignee's trade names and corporate names, and the right to sue for and be entitled to any damages for infringement of the Marks, but subject to the License.

3. Assignor agrees to take whatever further action is deemed necessary or appropriate by Assignee to properly and fully effect and perfect the transfer to Assignee of the Marks, and further, to aid and assist regarding documents or information in Assignee's possession as may be requested by Assignee in proceedings regarding the Marks, throughout the world.

4. The assignment of the Marks is subject to Assignor and its Affiliates (as directed by Assignor) receiving a non-exclusive, royalty-free license to use the Marks ("License").

As used herein, "Affiliate" means a person that directly, or indirectly through one or more intermediaries, controls, or is controlled by, or is under common control with, another person. "Control," including the terms "controlling," "controlled by" and "under common control with," means the ownership of or the ability to direct the voting of, either directly or indirectly, 50% or more of the outstanding voting equity interests of any corporation, partnership, unincorporated association or other entity.

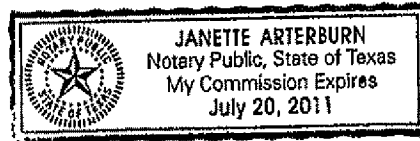




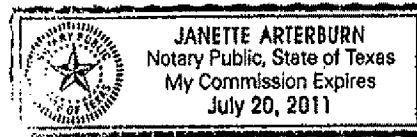
