This Confirmatory Assignment of Trademarks is made pursuant and subject to the Sale Agreement.

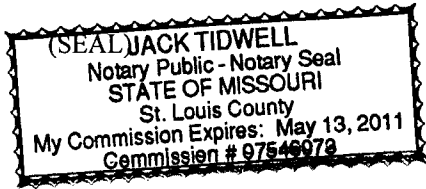
