AFFIDAVIT

I, the undersigned, being duly sworn, do hereby declare as follows:

1. Bank of America, N.A. is a corporation duly organized and existing under the Laws of Delaware and maintains an office at Suite 800, 300 Galleria Parkway, Atlanta, GA 30339, United States of America.
2. In 1998, NationsBank Corporation (including its subsidiary, Nationsbank of Georgia, N.A.) and Bank America Corporation merged, and NationsBank was subsequently renamed Bank of America Corporation. Bank of America, N.A. is a division of Bank of America Corporation and is a surviving entity of the merger.
3. As a surviving entity of the merger with and a successor in interest to the assets of NationsBank Corporation (including its subsidiary, Nationsbank of Georgia, N.A.), Bank of America, N.A. was the proper party to grant the Release of the Assignment of the Entire Interest of the mark that is the subject of U.S. Registration No. 1,069,353 for the mark SAF-T-LOCK that was granted to Nationsbank of Georgia, N.A. as Agent by Collins Industries, Inc., Capacity of Texas, Inc., Collins Bus Corporation, Collins Financial Services, Inc., Mobile-Tech Corporation, Transi-Corp., and Wheeled Coach Industries, Inc. pursuant to the Assignment Recorded May 19, 1995 on Reel 1390 and Frame 0349 with the US Patent and Trademark Office.

In the event, and to the extent, that the Release executed by Bank of America, N.A. which was Recorded on May 30, 2002 on Reel 2515 and Frame 0277 with the US Patent and Trademark Office, did not convey an Assignment of the Entire Interest of the mark that is the subject of U.S. Registration No. 1,069,353 for the mark SAF-T-LOCK from Bank of America, N.A. as a surviving entity of the merger with and a successor in interest to the assets of NationsBank Corporation (including its subsidiary, Nationsbank of Georgia, N.A.) to Collins Industries, Inc., World Trans, Inc., Mobile-Tech Corporation, Wheeled Coach Industries, Inc., Mobile Products, Inc., Capacity of Texas, Inc., and Collins Bus Corporation, Bank of America, N.A., as a surviving entity of the merger with and a successor in interest to the assets of NationsBank Corporation (including its subsidiary, Nationsbank of Georgia,

N.A.), hereby assigns, transfers and conveys to Collins Industries, Inc., World Trans, Inc., Mobile-Tech Corporation, Wheeled Coach Industries, Inc., Mobile Products, Inc., Capacity of Texas, Inc., and Collins Bus Corporation, any and all right, title and interest in and to the mark that is the subject of U.S. Registration No. 1,069,353 for the mark SAF-T-LOCK, and related property previously assigned to Nationsbank of Georgia, N.A. as Agent, including, but not limited to, all Collins Industries, Inc., Capacity of Texas, Inc., Collins Bus Corporation, Collins Financial Services, Inc., Mobile-Tech Corporation, Transi-Corp., and Wheeled Coach Industries, Inc.'s interests Assigned to Nationsbank of Georgia, N.A. as Agent Recorded May 19, 1995 on Reel 1390 and Frame 0349.
