
TRADEMARK ASSIGNMENT



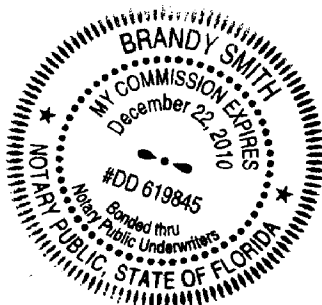


