ASSIGNMENT OF RCA TRADEMARKS (UNITED STATES)

This Assignment of RCA Trademarks (United States) (this "Assignment") is made as of December 31, 2007, by RCA Trademark Management, a société par actions simplifiée formed under the laws of France and having its registered office at 46 quai Alphonse Le Gallo, 921000 Boulogne, France ("Assignor"), in favor of Audiovox Corporation, incorporated under the laws of Delaware, and having its principal offices at 180 Marcus Boulevard, Hauppauge, New York 11788 ("Assignee") (each a "Party," and collectively, the "Parties").

WHEREAS, Assignor is the assignee of record for the United States trademark registrations and applications set forth on Exhibit A attached hereto (collectively, the "RCA Registrations"); and

WHEREAS, pursuant to the transactions contemplated under that certain (i) Purchase Agreement, dated October 14, 2007, as amended (the "Purchase Agreement") between Thomson, a société anonyme formed under the laws of France ("Thomson"), the parent of Assignor, and Assignee, and (ii) RCA Trademark Assignment Agreement (AV), dated as of even date herewith (the "RCA Assignment"), between Assignor and Assignee, the Parties wish to enter into this Assignment to evidence the transfer, conveyance and assignment by Assignor to Assignee of certain interests of Assignor in and to the RCA Registrations.

NOW, THEREFORE, in consideration of the foregoing, the Parties agree as follows:

Assignor hereby irrevocably transfers, conveys and assigns to Assignee all of Assignor's (and its affiliates') right, title and interest in and to the RCA Registrations, together with all goodwill associated therewith and all rights to causes of action and remedies related thereto (including, without limitation, the right to sue and recover damages and other relief for past, present or future infringement, misappropriation or violation of rights related to the foregoing).

The Parties acknowledge and agree that this Assignment is subject to, and shall be governed by, the RCA Assignment.




