**LIMITED RELEASE OF SECURITY INTEREST IN TRADEMARKS (FIRST LIEN)**

THIS LIMITED RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of December 31, 2007 (this "Limited Release"), is made by Wells Fargo Foothill, Inc., (a) in its capacity as administrative agent (in such capacity, the "Agent"), for itself and for the lenders (the "Lenders") party to that certain Credit Agreement, dated as of April 5, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among TB Wood's Corporation, TB Wood's Incorporated, Plant Engineering Consultants, LLC and TB Wood's Enterprises, Inc., as borrowers (collectively, the "Grantors"), the Agent and the Lenders, (b) in its capacity as administrative agent under that certain Security Agreement, dated as of April 5, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Grantors and the Agent, and (c) in its capacity as administrative agent under that certain Trademark Security Agreement, dated as of April 5, 2007 (as amended, restated, supplemented or otherwise modified from time to time and filed with the U.S. Patent and Trademark Office on April 11, 2007 (application number, 900074181A), the "Trademark Security Agreement"), among the Grantors and the Agent.

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, the Security Agreement and the Trademark Security Agreement, the Grantors granted to the Agent a security interest in certain of the Grantors' trademarks, including the trademarks set forth on Schedule 1 hereto, including the registrations and pending applications therefore and goodwill of the Grantors' business symbolized thereby (collectively, the "Applicable Trademark Collateral");

WHEREAS, pursuant to a Purchase Agreement dated as of December 18, 2007, among TB Wood's Incorporated, TB Wood's Enterprises, Inc., Altra Holdings, Inc., Vacon, Inc. and Vacon PLC (the "Purchase Agreement"), TB Wood's Incorporated, Plant Engineering Consultants, LLC and TB Wood's Enterprises, Inc. have sold certain assets, including the Applicable Trademark Collateral set forth on Schedule 1 hereto, and the Agent and the Lenders have consented to such sale and agreed to release the Agent's security interest in the sold assets (including the Applicable Trademark Collateral set forth on Schedule 1 hereto), pursuant to a Waiver and Consent Under Credit Agreement and Limited Release Under Security Agreement dated as of December 18, 2007; and

WHEREAS, the Agent wishes to further evidence the release of all its security interest in, to and under the Applicable Trademark Collateral set forth on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does, for itself and for the Lenders, hereby release all of its security interest in, to and under the Applicable Trademark Collateral set forth on Schedule 1 hereto, and discharges, quit claims and relinquishes (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in, to and under the Applicable Trademark Collateral set forth on Schedule 1 hereto (it being understood and agreed that other than the Applicable Trademark Collateral set forth on Schedule 1 hereto, the Agent and the Lenders have not released their security interest in, to and under any other Trademarks covered by the Security Agreement and the Trademark Security Agreement, and the Agent and the Lenders continue to have a perfected security in, to and under all such other Trademarks covered by the Security Agreement and the Trademark Security Agreement).
