The corporation, Thurgood Marshall Scholarship Fund, organized and existing under the laws of the State of Delaware, hereby certifies as follows:


(1) That at a meeting a vote of the members of the governing body was taken for and against the First Amendment to the Certificate of Incorporation, said Amendment being as follows:
