THIS AMENDED AND RESTATED GRANT OF TRADEMARK SECURITY INTEREST, dated as of July 10, 2004 is entered into by and among: (1) THE WINE GROUP LLC, a Delaware limited liability company (the "Company"); (2) THE WINE GROUP, INC., a California corporation and Manager of the Company (the "Manager"); (3) LONE TREE CREEK VINEYARDS, LLC, a Delaware limited liability company; (4) SMALLWOOD VINEYARDS, LLC, a California limited liability company; (5) NORTHWOOD VINEYARDS, LLC, a California limited liability company; (6) GOLDEN STATE VINTNERS, INC., a Delaware corporation; (7) GOLDEN STATE VINTNERS, a California corporation; and (8) GSV BOTTLING, LLC, a California limited liability company (each a "Grantor" and collectively the "Grantors").

WHEREAS, Grantors own and use in their business, and will in the future adopt and so use, various intangible assets, including the Trademark Collateral (as defined below); and

WHEREAS, the Manager and the Company (together, the "Borrowers") have entered into separate Note Purchase Agreements dated as of August 30, 2002 (said Note Purchase Agreements, as they may heretofore have been and as they may hereafter be amended, supplemented, restated or otherwise modified from time to time, collectively being the "Note Purchase Agreement") with the holders of the Notes issued thereunder (the "Senior Noteholder Notes") party thereto (collectively, together with their respective successors and assigns party to the Note Purchase Agreement from time to time, the "Senior Noteholders") pursuant to which Senior Noteholders have purchased the Senior Noteholder Notes from Borrowers, subject to the terms and conditions set forth in the Note Purchase Agreement; and

WHEREAS, the Borrowers have entered into an Amended and Restated Credit Agreement dated as of July 10, 2004 (said Credit Agreement, as it may heretofore have been and as it may hereafter be amended, supplemented, restated or otherwise modified from time to time, being the "Credit Agreement") with the financial institutions named therein (collectively, together with their respective successors and assigns party to the Credit Agreement from time to time, the "Lenders"), and Cooperative Centrale Raiffeisen – Boerenleenbank B.A., "Rabobank International", New York Branch ("Rabobank") (as assignee of JPMorgan Chase Bank), as Administrative Agent for the Lenders (in such capacity, "Agent"), pursuant to which Lenders have made certain commitments, subject to the terms and conditions set forth in the Credit Agreement, to extend certain credit facilities to Company; and

WHEREAS, the Borrowers may from time to time enter into one or more additional note purchase agreements and/or credit agreements and/or swap agreements (the "Additional Agreements") with investors and/or lenders and/or swap providers which become parties to the Intercreditor Agreement (as defined below) pursuant to Section 5.06 thereof (such investors, lenders and swap providers being referred to herein

as the "Additional Creditors) in accordance with the terms of the Intercreditor Agreement referenced below; and

WHEREAS, Senior Noteholders, Lenders and Rabobank, as Collateral Agent for and representative of the Senior Noteholders, Lenders and Additional Creditors (in such capacity herein called "Secured Party") have entered into, and upon their execution of a Counterpart, Additional Creditors will enter into that certain Collateral Agency and Intercreditor Agreement dated as of August 30, 2002 (said Collateral Agency and Intercreditor Agreement, as it may heretofore have been and as it may hereafter be amended, supplemented, restated or otherwise modified from time to time, being the "Intercreditor Agreement"), pursuant to which Senior Noteholders and Lenders have appointed, and upon their execution of such Counterpart, Additional Creditors will appoint, Secured Party, and Secured Party has agreed to act, as collateral agent for the Senior Noteholders, Lenders and Additional Creditors hereunder; and

WHEREAS, each Grantor that is a Subsidiary of the Borrowers has guaranteed all present and future obligations to Senior Noteholders under the Note Purchase Agreement and all present and future obligations to Lenders under the Credit Agreement and all present and future obligations to Additional Creditors under any Additional Agreement; and

WHEREAS, pursuant to the terms of the Security Agreement dated as of August 30, 2002 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), between the Grantors and Secured Party, the Grantors have agreed to create in favor of Secured Party a secured and perfected interest in, and Secured Party has agreed to become a secured creditor with respect to, the Trademark Collateral; and

WHEREAS, certain Grantors and Rabobank (as assignee of JPMorgan Chase Bank), as Collateral Agent, are parties to a Grant of Trademark Security Interest dated as of August 30, 2002 (as amended, supplemented or otherwise modified prior to the date hereof, the "Original Trademark Security Agreement"); and

WHEREAS, the Grantors and Rabobank (as assignee of JPMorgan Chase Bank), as Collateral Agent, desire to amend and restate the Original Trademark Security Agreement in its entirety hereby; and

WHEREAS, when used herein, the term "Obligations" shall have the meaning given to such term in the Intercreditor Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Security Agreement, each Grantor party to the Original Trademark Security Agreement hereby reaffirms that the security interest granted to the Secured Party in all of such Grantor's right, title and interest in the Trademark Collateral (as defined below) under the Original Trademark Security Agreement are valid and perfected security interests securing the Obligations. Additionally, as security for the payment and performance of

the Obligations, each Grantor hereby further grants to Secured Party a security interest in all of such Grantor's right, title and interest in and to the following, in each case whether now or hereafter existing or in which such Grantor now has or hereafter acquires an interest and wherever the same may be located (the "Trademark Collateral"):

(i) all rights, title and interest (including rights acquired pursuant to a license or otherwise but only to the extent permitted by agreements governing such license or other use, unless any non-permissibility is not enforceable under applicable law) in and to all trademarks, service marks, designs, logos, indicia, trade names, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto, owned by such Grantor, or hereafter adopted and used, in its business (including, without limitation, the trademarks specifically identified in Schedule A) (collectively, the "Trademarks"), all registrations that have been or may hereafter be issued or applied for thereon in the United States and any state thereof and in foreign countries (including, without limitation, the registrations and applications specifically identified in Schedule A) (the "Trademark Registrations"), all common law and other rights (but in no event any of the obligations) in and to the Trademarks in the United States and any state thereof and in foreign countries (the "Trademark Rights"), and all goodwill of such Grantor's business symbolized by the Trademarks and associated therewith (the "Associated Goodwill"); and

(ii) all proceeds, products, rents and profits of or from any and all of the foregoing Trademark Collateral and, to the extent not otherwise included, all payments under insurance (whether or not Secured Party is the loss payee thereof), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise with respect to any of the foregoing Trademark Collateral. For purposes of this Grant of Trademark Security Interest, the term "proceeds" includes whatever is receivable or received when Trademark Collateral or proceeds are sold, exchanged, collected or otherwise disposed of, whether such disposition is voluntary or involuntary.

Each Grantor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.


