Whereas, an Agreement and Plan of Merger, dated September 1, 2006 by and between CHASE INSURANCE LIFE AND ANNUITY COMPANY, a stock legal reserve company organized and existing under and by virtue of the laws of the State of ILLINOIS and CHASE INSURANCE LIFE COMPANY, a stock legal reserve company organized and existing under and by virtue of the laws of the State of ILLINOIS and PROTECTIVE LIFE INSURANCE COMPANY, a stock legal reserve company organized and existing under and by virtue of the laws of the State of TENNESSEE, whereby the said CHASE INSURANCE LIFE AND ANNUITY COMPANY and CHASE INSURANCE LIFE COMPANY are being merged into the said PROTECTIVE LIFE INSURANCE COMPANY, the surviving company, has been presented to the Director of Insurance of the State of Illinois for approval;

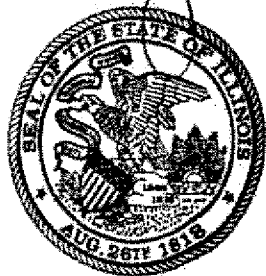
IT IS, THEREFORE, ORDERED that said Agreement and Plan of Merger be and the same is hereby approved to be effective April 1, 2007.
