ASSIGNMENT

WHEREAS Dekko Technologies, LLC (the Assignor), a limited liability company organized and existing under the laws of the state of DELAWARE, and having a place of business at 11766 Wilshire Boulevard, Los Angeles, California 90025, is the owner of the entire right, title and interest in and to the trademark "LYALL" which is the subject of U.S. Trademark Registration No. 1,811,923, issued December 21, 1993;

Assignor shall provide Assignee, its successors and assigns or other legal representatives, reasonable cooperation and assistance at Assignee's request and at Assignee's reasonable expense (including the execution and delivery of any and all affidavits, declarations, oaths, assignments, powers of attorney or other documentation as may be reasonably required) in the preparation and prosecution of any applications covering the LYALL trademark assigned herein; in the
