**CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION OF
FT MORTGAGE COMPANIES**

The undersigned, the Senior Vice President and the Assistant Secretary, respectively, of **FT MORTGAGE COMPANIES**, a Kansas corporation (hereinafter referred to as the "Corporation"), do hereby certify that on the 1st day of December, 1999, the following resolutions, inter alia, were adopted by the Sole Director and the Stockholder entitled to vote thereon:

WHEREAS, a Certificate of Amendment of Articles of Incorporation of Carl I. Brown and Company, dated July 20, 1995 and filed on July 21, 1995 with the Secretary of State of the State of Kansas at Book 4636, page 623, restated and amended Article I of the Articles of Incorporation of the Corporation changing the name of the Corporation from Carl I. Brown and Company to FT Mortgage Companies; and

WHEREAS, the Corporation now wishes to amend its name from FT Mortgage Companies to "First Horizon Home Loan Corporation".

NOW, THEREFORE, BE IT RESOLVED, that effective March 4, 2000, the Articles of Incorporation of the Corporation are hereby amended again to change the name of the Corporation from FT Mortgage Companies to "First Horizon Home Loan Corporation", and Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and the following restated and amended Article I substituted therefore:

"ARTICLE I

The name of the Corporation is First Horizon Home Loan Corporation."

FURTHER RESOLVED, that Pamela J. Detrow, Vice President for the Corporation and/or her designees are authorized and directed to file with the Secretary of State of the State of Kansas the appropriate Certificate of Amendment as required by the Kansas General Corporation Law, and the proper officers of the Corporation be and they are hereby authorized to take any and all action to execute, acknowledge, seal and file any and all instruments and documents necessary or proper in connection therewith, to the same extent and purpose as if the name of the Corporation has always been "First Horizon Home Loan Corporation".

The undersigned further certify that the foregoing was duly adopted in accordance with the provisions of K.S.A. 17-6602.
