
NOW THEREFOR, for good and valuable consideration, the receipt and adequacy of which is hereby freely acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee, its successors, legal representatives and assigns, free and clear of all liens and encumbrances, the entire right, title and interest of Assignor in and to the Marks, together with all of the goodwill of the entire business associated with and symbolized by such Marks, the registration thereof, and all rights and privileges under each of the Marks, including the right to renew and otherwise prosecute the registration of each of the Marks, in the United States, and all rights to recover for damages and profits for infringement in the United States, and throughout the world.

After execution of this Trademark Assignment, at the request of the Assignee and at the Assignee's expense, but without additional consideration to the Assignor, the Assignor will execute and deliver to the Assignee from time to time such further instruments of conveyance, transfer, and assignment and other documents, and will take such other actions, as the Assignee may reasonably require to convey and deliver more effectively to the Assignee the Marks, to perfect the Assignee's title thereto, and otherwise to accomplish the orderly transfer to the Assignee of the trademark and to give full effect to this Trademark Assignment.

This Trademark Assignment is binding on the Assignor and its respective successors, heirs and assigns, and inures to the benefit of the Assignee and its successors and assigns.
