**RELEASE OF SECURITY INTEREST AND REASSIGNMENT  
IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST AND REASSIGNMENT** is made effective as of December 21, 2007, by Bank of America, N.A. ("BofA"), as successor in interest to Fleet Capital Corporation, having an address at 300 Galleria Parkway, NW, Suite 800, Atlanta, Georgia 30339.

**WHEREAS**, pursuant to that certain Collateral Patent, Trademark and License Agreement dated February 27, 1998 (the "**Collateral Agreement**"), and recorded with the United States Patent and Trademark Office on March 4, 1998, at Reel/Frame 1693/0690, Visador Acquisition Company, L.L.C. ("**Visador Acquisition**") granted, bargained, assigned, mortgaged, pledged, sold, created a security interest in, transferred and conveyed to BofA, all of Visador Acquisitions' right, title and interest in and to the Trademarks (as defined in the Collateral Agreement) including, without limitation, the mark set forth on Schedule A (collectively, the "**Marks**"), together with the goodwill of the business connected therewith and symbolized thereby;

**WHEREAS**, on February 27, 1998, Visador Acquisition changed its name to Visador Company, LLC, which, on March 13, 2000, changed its name to Coffman Stairs, LLC ("**Coffman Stairs**");

**WHEREAS**, on July 31, 2001, Coffman Stairs granted a security interest in the mark set forth on Schedule A to BofA as recorded with the United States Patent and Trademark Office on July 2, 2002, at Reel/Frame 2536/0409 (the "**Security Agreement**"); and

**WHEREAS**, the obligation underlying the Collateral Agreement and the Security Agreement is no longer owed and BofA no longer has an interest in the Marks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BofA hereby releases its security interest in the Marks and reassigns to Coffman Stairs any and all rights conveyed under the Collateral Agreement and the Security Agreement in the Marks, together with the goodwill of the business connected therewith and symbolized thereby, as if the Collateral Agreement and Security Agreement had never been entered into by Visador Acquisition and Coffman Stairs, respectively.
